# Bishop's Report to the 2025 Assembly of the Northern Great Lakes Synod



Dear Northern Great Lakes Synod, Grace and peace to you!

We continue in the second year of our three-year theme under the banner of "Seed Sowers" focusing on the scripture passage from I Corinthians 6: "I planted, Apollos watered, but God gave the growth."

In the first year, we considered what it means to **plant** seeds of faith. In this second year, we focus on the **watering** of those seeds. How do we encourage seeds to grow? While I have mentioned that you cannot make a bean grow by pulling on it, there are actions we can take to nurture faith and ministry and provide what is needed for optimal conditions for growth.

As a Synod, we are currently nurturing seeds of faith in the following ways:

**Lifelong Faith Formation:** In both the Spring and Fall, a variety of classes are offered.

**Devotional Resources:** The Seed Sower devotional guide provides focused discussion for any congregational or family gathering or meeting.

**Prayfaithfully Devotions:** Online daily devotions written by NGLS members, lay and clergy, across our synod.

**Christmas Worship Service:** Broadcasted on WLUC TV6, this program nurtures seeds of faith in ways we will never know. But it is worth doing anyway.

# The Annual Synod Ministry Fund:

In 2024 and into 2025, \$4,050 was disbursed to the following ministry efforts:

- 1. The Ishpeming Community Good Friday Cantata.
- 2.Feed My Sheep kitchen upgrades at Lutheran Campus Ministry through Good Shepherd, Houghton and Michigan Tech.
- 3. Wild Church Convocation of leaders
- 4. Dinner Church at Trinity, Rhinelander.
- 5. Financial support for adult volunteers attending the Youth Extravaganza.



In 2024, \$7,311 was raised thanks to the generosity of individual donors. Up to 90% of these funds are now available for disbursement in 2025. Find the application form on our Synod website.

Seeds of faith are being nurtured through Lutheran Campus Ministry at MTU, NMU, and Bay College, through our Synod Youth Ministry efforts, through our partners Fortune Lake Lutheran Camp and U.P. Wild Church. Seeds of relationship building are being nurtured through Walking with Our Indigenous Neighbors. Seeds of future ministry will be nurtured through the legacies of St. James, Marinette and Holy Cross, Baraga. Check out additional reports that describe the ministry efforts that we do together beyond any single congregation.

As we focus on watering seeds of faith, we participate in the shape of the Christian life. We remember seasons of growth and change, seasons of dormant waiting, seasons of dying and rising. We nurture seeds with our witness, our financial resources, our participation in ministry and congregational life, and more. And unlike our summer gardens, we nurture seeds now that we may not live to see bloom and bear fruit.

I thank God for the seeds of faith that were planted and watered years ago that bless us now. I hope, together, we will plant and water seeds for future generations to enjoy as the body of Christ lives as the Church in a tomorrow beyond our sight.

# Report of the Assistant to the Bishop & Director of Evangelical Mission (DEM)

"Blessed are they who plant trees under whose shade they will never sit."

This is the proverb my predecessor and co-worker in Christ, Rev. Jim Duehring, quoted to begin his report to the 2024 Assembly. I am so very grateful for his legacy, and the trees he planted across our synod, in which we all enjoy the shade. Pr. Jim retired in August of 2024. Following Pr. Jim's retirement, this work was faithfully stewarded by retired pastor, Rev. Steve Solberg, from September 2024 to January 2025 when I began to work among you.

In my first months among you, I have witnessed the synod culture that is grown and growing in the Northern Great Lakes Synod through the work of Bishop Katherine Finegan and the expansive synod team (including you). It is interconnected, creative, rooted, and joyful in the company of one another. By the first part of March, I had already been welcomed in thirteen of our seventy-seven worshipping communities with grace, hospitality, and joy. Folks are eager and earnest to be God's faithful community together. There is shared joy and hope, as well as shared challenges. And God's presence in the midst of all of it.

For the sake of naming the obvious and our collective learning, let me re-state what my role is among you. I am both Assistant to the Bishop, as well as the Director of Evangelical Mission, (for which our synod receives some financial support.)

The role of **Assistant to the Bishop** is to support and facilitate the work of Bishop Finegan across the synod, as well as our work together in equipping the saints for ministry. In our first months together, Bishop Finegan and I have been learning how my interests, gifts, and experience, best support our shared work and needs of the synod. Thus far, the lay-led/staff supported ministries in our synod that I directly relate to are:

- Generosity and Stewardship
- Youth Committee
- Christ's Kaleidoscope and Walking with Our Indigenous Neighbors
- Equipping for safer boundaries
- Congregations in Transition (Bp. Finegan and I share this responsibility by relating with different congregations around the synod)
- Constitutions Committee
- Companion Synod partnership with Eastern & Coastal Diocese of the Evangelical Lutheran Church in Tanzania
- Evangelical Mission
- World Hunger

The role of the **Director of Evangelical Mission (DEM)** is to help enliven and equip the synod in the Vision and Purpose of the ELCA. This vision is of a world experiencing the difference God's grace and love in Christ make for all people and creation. The purpose of our work, so that this vision may be realized, is to activate each of us so more people know the way of Jesus and discover community, justice, and love. The Director of Evangelical Mission position was imagined over a decade ago, to have someone deployed in each synod, waking up every morning, jumping into boots to be both activated and activating in this vision and purpose. How can we be more alive in Christ, together? How are we sharing the good news of Christ in our communities in ways that the community, justice, and love we have experienced overflows to others around us? To help make that work a reality, DEMs can help new ministries connect with resources and matching grants, so that the good news of Christ is amplified and activated in our communities. The ministry "trees" that I am blessed to continue to help steward, are ones that Pr. Jim Duehring planted, and Pr. Steve Solberg watered, and God will continue to give the growth:

• UPWild and UPWild Keweenaw... Synodically Authorized Outreach Ministries, with shared support with the Episcopal Diocese in Northern Michigan for mission developer, Lanni Lantto.

- Youth Advocacy Retreat for 2025
- Dinner Church at Trinity Evangelical in Rhinelander, recipient of an ELCA Evangelism and Synod Ministry Grant

The two roles, Assistant to the Bishop (A2B) and Director of Evangelical Mission (DEM), in other synods are sometimes filled by two (or more) people. The Northern Great Lakes Synod has a long history of having these roles shared in one person. It is this structure that has helped guide how the responsibilities are shared. The Assistant to the Bishop work cannot be pulled apart from seeking ways to activate each of us so more people know the way of Jesus and discover community, justice, and love through our congregations and outreach ministries.

My favorite part of being with you, thus far, is getting to reflect back to you what God is already doing among you. I see it in the hospitality you share with me and your community. I see it in the creative and expansive wonder you embrace when met with a new challenge. I see it in the care and compassion you have for one another and neighbors in your wider community. I see it all around, in this beautiful place we steward and share, for the sake of future generations, and creation itself. I see it in your embrace of death and dance with new life, as an Easter people. You are God's beloved...which has no borders or boundaries, in time or place, but is unique and called to purpose.

# **Report of the Synod Vice President**

Throughout my working career, my focus was on groundwater protection and drinking water quality. Even now in retirement, water quality and the general well-being of God's gift of nature continues to be my focus. The Synod's theme for this year, *Apollos Watered*, could fittingly correspond with my personal focus and activities of the past year and current year. While the verse from 1 Corinthians 3:6, *I planted*, *Apollos watered*, *but God gave the growth*, traditionally refers to nurturing seeds of faith, I choose to interpret "watered" more literally, applying it to the call of caring for God's creation.

Considering the call to care for creation, myself and three others from the Northern Great Lakes Synod (NGLS) will attend the 8<sup>th</sup> *EcoFaith Summit of the Upper Midwest* in Duluth in early April. The NGLS is joining as a partner synod for the 2025 Summit, which is titled *Earth's Cries, Earth's Call: Becoming Midwives of Hope for the Healing of Creation*. I look forward to sharing about our Summit learnings during my oral report at this year's Synod Assembly.

This past year I joined the InterFaith Water Stewards Initiative, a program of the Cedar Tree Institute in Marquette. As part of this effort, I had the privilege of being the keynote presenter at an October 2024 Community Forum at Messiah Lutheran Church in Marquette. I discussed the challenges of ensuring quality drinking water in the Upper Peninsula. This spring, I will facilitate a second forum, which will feature speakers presenting differing viewpoints on the issue of fluoride in drinking water. Additionally, I wrote an article for the December 2024 issue of *Marquette Monthly*, highlighting how the region's water resources may not be as pure as commonly believed, and urging us all to take greater responsibility for caring for God's creation.

With my current focus on caring for creation, during the fall 2024 Lifelong Faith Formation term I led a class on the 2023 ELCA Social Message, "The Earth's Climate Crisis." Using a study guide from the ELCA, we delved into the scriptural basis for the social message, discussed why we should be concerned, and reflected on what are we called to do about it. I am currently working on curriculum for a follow-up class on the ELCA Social Statement, "Caring for Creation."

At Synod Assembly this year I will lead a workshop on the Evolution of an ELCA Social Teaching. We will explore the origins of ELCA social teachings, what the process from start to finish includes, and how each of us can influence both the development of these teachings and the content of the final product.

To be faithful to God and to the ministry of the NGLS and the ELCA, as your Synod Vice President I participated in the activities, committees, and meetings listed below since my last report to you for the 2024 Synod Assembly.

#### On a synod and churchwide level:

# **Report of the Synod Treasurer**

# Results of the Fiscal Year Ended January 31, 2025

### **Unrestricted Income and Expenses**

Our Northern Great Lakes Synod (NGLS) wrapped up its 2024 fiscal year on January 31, 2025, and we were in a better position than we had projected, thanks, in part, to the generosity of a number of NGLS congregations as well as some noteworthy personnel changes. Our Assistant to the Bishop, Pr. Jim Duehring, retired, and the Synod's Office Administrator, Courtney Wehmeier, left the area for an advanced degree. Based on NGLS Pre-Audit numbers, while we had budgeted for a deficit of \$17,039, we ended the fiscal year with a budget surplus of \$23,031, a difference of just over \$40,000 on the plus side. Unrestricted Congregation Benevolence Support was budgeted at \$729,507, and actual income was \$740,555, an increase of \$11,048. At the same time, Unrestricted Expenses were budgeted at \$749,846, with actual coming in at \$721,428, a difference of approximately \$28,418. Increases in the expenses area include approximately \$15,000 in Ministry Through ELCA, and decreases included the following: \$2,000 in Ministry Through Partnerships, \$2,500 in the Organization, and \$28,646 in Synod Personnel. Total income was \$744,459 and total expenses were \$721,428, leading to the surplus figure of approximately \$23,000.

We are pleased to report that, from an Unrestricted Income perspective, 78 congregations in the NGLS contributed to mission support and, 46 congregations met their pledge, and 21 more exceeded their pledge. We give thanks for our congregations' generosity and faithfulness in giving.

Forty-three percent, or \$318,438, of Benevolence Support was sent on to the Churchwide organization to support ministry through the Evangelical Lutheran Church in America (ELCA). Other Unrestricted Benevolence Support dollars were used for Partnerships such as Campus Ministries and Seminary Partners, with the remaining Unrestricted Income used for NGLS Programs, Organization, Office, and Personnel expenses.

#### Restricted Income and Expenses

Restricted Benevolence Income receipts for Fiscal Year 2024 were at \$664,065, \$169,376 over FY2023 and exceeding budget estimates of restricted giving. Restricted Benevolence Income included gifts of approximately \$93,000 to World Hunger and \$30,000 to Fortune Lake. Restricted Income is also received from sources, including Grant Funding, Pass Through Gifts from Congregations and Individuals, Endowment Distributions, and Fees. Because these funds are restricted to specific ministries, they cannot be used for operational expenses that are funded with unrestricted dollars.

There are many budgeted areas covering Restricted Expenses, and they fall under broad categories, including Congregational Ministries such as Youth Programming; Ministry in the areas of Seminarian Support, Leadership Support, Pastors' Debt Retirement, and Lifelong Faith Formation; Mission Outreach such as Tanzanian Relationship-Building and U.P. Wild Support; and a variety of other areas, including our Regional Gift Planner, Website Hosting and Maintenance, and Synod Assembly.

There are three NGLS positions receiving Restricted Expense Funding, and they are portion of the Assistant to the Bishop costs (a Grant-Funded Salary of \$35,001 in FY2024), the Youth Ministry Coordinator costs (restricted funds of \$12,000 in FY2024), and the Lifelong Faith Formation/LLM Coordinator costs (restricted funds of \$5,000).

### Audit Report for the Fiscal Year Ended January 31, 2024

During the week of March 17, 2025, an audit of the NGLS Financials was in process through the Certified Public Accounting firm of Andrews, Hooper, Pavlik, PLC. The Independent Auditor's Report along with Financial Statements are expected to be available elsewhere within the 2025 Pre-Assembly Report.

### Proposed Amended FY2025 Budget and Proposed FY2026 Budget

The Income and Expense Statement for 12 Months Ending January 31, 2025, as well as the Amended and Proposed FY2025 Budget, and Proposed FY2026 budget are available elsewhere within the 2025 Pre-Assembly Report. Please note the separate sections and columns for "Unrestricted" and "Restricted" amounts. As noted above, because restricted funds are expended for specific ministries, they cannot be used for operational expenses that are funded with unrestricted dollars. A separate document showing the Synod Personnel Budget can also be found elsewhere within the 2025 Pre-Assembly Report.

### **Treasurer's Reflection**

I am grateful for all who are working together to support the financial position of the Northern Great Lakes Synod. First, I want to thank our congregations, their pastors and leaders, for making Benevolence a priority. I thank the Synod Finance Committee members, Naomi Fletcher, Kay Johnson, Peter Johnson, and Sarah Sleeter, for their work on the 2025/2026 budgets along with the Synod Ministry Fund grants. I thank the Audit Committee members, Ken Groh and Karen Kolstad, for being part of the audit review process. I am grateful for the work of the Endowment Ministry Committee members, Kathy Bero, Ann Christiansen, David Holli, Dirk Manson, Chuck Thomas, and Karin VanDyke, as they continue overseeing Endowment ministry and preparing for the second Seed Sowers Luncheon. Thank you to Courtney Wehmeier and Naomi Mattson, who provided office support in 2024, and to Eva Hautamaki who joined the Synod in February. I give thanks for Bishop Katherine Finegan, for now-retired Pr. Jim Duehring, as well as for our new Assistant to the Bishop and Director of Evangelical Mission Pr. Sharolyn Swenson Synod leadership provides the vision for the Synod's future financial needs. Finally, I give my sincerest thanks to Betsy Koski whose commitment to the financial well-being of our synod is unsurpassed. She makes the work of the Endowment, Finance, and Audit Committees much easier thanks to her knowledge, understanding, and abilities. Betsy's willingness to steward the synod's limited resources with such detail aids us in making the best possible decisions. I am very grateful for Betsy's commitment to this Synod, and I look forward to working with her for another year. Thank you one and all.

# Report of Independent Auditors

Synod Council Northern Great Lakes Synod of the Evangelical Lutheran Church in America Marquette, Michigan

### Opinion

We have audited the accompanying financial statements of Northern Great Lakes Synod of the Evangelical Lutheran Church in America (a not-for-profit organization), which comprise the statement of financial position as of January 31, 2025, and the related statements of activities, functional expenses, and cash flows for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Northern Great Lakes Synod of the Evangelical Lutheran Church in America as of January 31, 2025, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

#### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Northern Great Lakes Synod of the Evangelical Lutheran Church in America and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Northern Great Lakes Synod of the Evangelical Lutheran Church in America's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

### Auditor's Responsibilities for the Audit of the Financial Statements

# 1. Summary of Significant Accounting Policies

# Nature of Operations

Northern Great Lakes Synod of the Evangelical Lutheran Church in America (Synod) is one of the 65 synodical units of the Evangelical Lutheran Church in America (ELCA). The Synod operates as a religious organization. The Synod serves 79 congregations across 8 conferences in the Upper Peninsula of Michigan and Northeastern Wisconsin. Church ministry is promoted through programs that involve congregational life and mission, ministry development, mission outreach, and justice advocacy. The Synod is primarily supported through contributions from member congregations.

The accompanying financial statements include only those funds for which the Synod retains operational control and exclude the accounts of the individual congregations which it serves.

#### Financial Statement Presentation

The Synod's financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles for not-for-profit organizations in the United States of America. Under this guidance, the Synod is required to report information regarding its financial position and activities based on the existence or nature of any donor-imposed restrictions.

Net Assets Without Donor Restrictions – Represent funds available for support of current Synod operations or designated by the Synod for specific use.

Net Assets With Donor Restrictions – Represent funds whose use is limited by donorimposed stipulations. Some donor-imposed restrictions are temporary in nature, such that they expire either by passage of time or fulfillment of the stipulations. Other donorimposed restrictions are perpetual in nature, where the donor stipulates resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both.

#### Income Taxes

The Synod is exempt from income taxes under Internal Revenue Code Section 501(c)(3) and is not a private foundation. The Synod does not file a federal tax return due to its religious designation.

### 1. Summary of Significant Accounting Policies (continued)

### Cash and Cash Equivalents

For purposes of the statement of cash flows, the Synod considers all cash and unrestricted highly liquid investments with an initial maturity of three months or less to be cash and cash equivalents; however, for the purposes of the statement of cash flows, investment funds held as cash in checking and cash equivalents held by investment managers are reported as investments rather than cash equivalents.

#### Investments

Investments are carried at fair value with realized and unrealized gains and losses included in the statement of activities.

# Property and Equipment

Fixed asset acquisitions over \$500 are recorded at cost or, if donated, at the approximate fair value at the date of donation. Depreciation is provided over the estimated useful lives of the respective assets (or the term of the lease, in the case of leasehold improvements) on a straight-line basis.

#### Leases

The Synod enters into leases in the normal course of business and recognizes right-of-use assets and lease liabilities associated with leases based on the present value of the future minimum lease payments over the lease term at the commencement date. Lease terms reflect options to extend or terminate the lease when it is reasonably certain that the option will be exercised. Right-of-use assets and lease liabilities are not recognized for short-term leases (leases with an original lease term of 12 months or less) or in certain other instances where the Synod has determined the amounts would be immaterial to the financial statements.

Leases are classified as operating or finance leases at the lease commencement date. Lease expense for operating leases and short-term leases is recognized on a straight-line basis over the lease term.

#### Funds Held for Others

The Synod is the administrator of funds received for specified beneficiaries. The Synod invests and remits these funds to the specified beneficiaries in accordance with the governing documents. Such amounts are recorded as a liability until released to the beneficiaries.

# Revenue Recognition

Revenue is recognized when earned. Revenue from program fees is recognized at the point in time when the services are provided. The Synod recognized \$25,308 of total revenue under FASB Accounting Standards Codification 606, Revenue from Contracts with Customers, for the year ended January 31, 2025.

Revenue from contributions is recognized at the time an unconditional promise to give or transfer of assets is made. Cost reimbursement grants are recognized as revenue in the period the qualifying allowable expenditures are incurred.

#### Donated Services

The Synod receives a significant amount of donated services from unpaid volunteers who assist in special projects. No amounts have been recognized in the statement of activities because the criteria for recognition under generally accepted accounting principles for not-for-profit organizations in the United States of America have not been satisfied.

# Functional Allocation of Expenses

Expenses have been allocated among program and support services either by directly charging such costs to the specific programs and activities to which they relate or allocating among the program and supporting services benefited.

#### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

# Subsequent Events

Subsequent events were evaluated for potential recognition or disclosure in the financial statements through April 7, 2025, the date the financial statements were available to be issued.

<u>ELCA Mission Investment Fund (MIF)</u>: The MIF is available for exclusive investment by ELCA-related institutions. The investment represents a demand deposit carried at cost, which approximates fair value.

<u>ELCA Endowment Fund Pooled Trust – Ministry Growth Fund (Fund)</u>: The Fund was established to allow for the collective long-term investment of funds belonging to the ELCA, its congregations, synods, seminaries, and other eligible affiliated entities. The Fund is managed and invested by professional advisors. The target allocation of the Fund is a diversified portfolio of investments including U.S. and non-U.S. equities, global fixed income securities, private markets, cash equivalents and alternative investments.

# 3. Investments (continued)

<u>ELCA Endowment Fund Pooled Trust – Ministry Growth Fund (Fund) (continued):</u> The Fund is structured to provide participants with a stable, quarterly stream of distributable income that grows over time approximately in line with the expected long-term rate of inflation. The Fund also seeks to provide participants with long-term capital appreciation. The investment is carried at fair value, based on the net asset value of the units held by the Synod.

<u>Cash Surrender Value of Life Insurance</u>: The Synod is the owner and beneficiary of two life insurance policies representing a total face value of \$11,000. The policies are carried at the cash surrender value, which approximates fair value.

### 4. Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels:

- Level 1: Unadjusted quoted prices in active markets for identical assets that are accessible at the measurement date.
- Level 2: Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; or inputs that are observable, either directly or indirectly.
- Level 3: Inputs are unobservable, that is, the inputs are supported by little or no market activity.

The Synod uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

### 8. Lease

In July of 2018, the Synod entered into a 10-year lease for its administrative office that expires June 30, 2028. Per the lease terms, the payments increase 2% annually. The discount rate used was 3.0%, which represented a risk-free rate of return. The Synod has classified this lease as an operating lease. # 9. Related Party Transactions

The Synod follows guidelines and policies as set by the ELCA. The ELCA awarded the Synod \$73,083 in grants for the year ended January 31, 2025.

The Synod supported the ELCA by contributing 43 percent of congregational contributions, which totaled \$318,438 for the year ended January 31, 2025. As of January 31, 2025, accounts payable included \$6,976 owed to the ELCA for general support.

Support and revenue on the statement of activities includes \$125,186 of designated contributions that were remitted to the ELCA for various ELCA programs. As of January 31, 2025, accounts payable included \$1,144 owed to ELCA for designated support.

The Synod leases office space from a member church under a non-cancelable lease that expires June 30, 2028. The total amount paid to this member church totaled \$15,899 for the year ended January 31, 2025.

### 10. Pension Plan

The Synod participates in a multi-employer defined contribution pension plan administered by Portico Benefit Services (Portico), which covers all full-time Synod personnel. The Synod has no liability for current or prior service pension costs other than to pay fixed amounts based on contribution rates set by Portico as a percentage of salaries. Contributions to the plan totaled approximately \$33,400 for the year ended January 31, 2025.

### 11. Endowment Funds

As of January 31, 2025, Synod endowments consist of the General Endowment Fund, the St. Mark's Legacy Endowment Fund, the Bishop Thomas and Luanne Skrenes Fund for Ministry, and the Norman Lamberg Clergy Debt Relief Fund. These funds were established by donors to provide annual funding for specific activities and general operations of the Synod.

The General Endowment Fund is restricted for furthering the growth of the Church, its ministries and stewardship opportunities, and support of seminarians, apart from general operations of the Synod, with the primary objective of preservation of the purchasing power (real value) of the endowment funds.

The Bishop Thomas and Luanne Skrenes Fund for Ministry is to provide financial support for clergy debt retirement, as well as projects within a companion synod, the Eastern and Coastal Diocese of the Evangelical Lutheran Church in Tanzania.

The Norman Lamberg Clergy Debt Relief Fund is to provide financial support for clergy debt relief.

The Synod Council and Endowment Fund Committee interpret contributions to the General Endowment Fund, the Bishop Thomas and Luanne Skrenes Fund for Ministry, and the Norman Lamberg Clergy Debt Relief Fund as being temporarily restricted, as these funds are subject to appropriation of expenditure in amounts in excess of the annual spending policy as per the Synod's Constitution and Bylaws.

The Constitution and Bylaws cite that, with the recommendation of the Synod Council, the Endowment Fund Committee, and adoption by at least two-thirds of those present and voting at a Synod Assembly, the Synod may disburse any fund principal or corpus.

The St. Mark's Legacy Endowment Fund was established with the proceeds of assets of St. Mark's Lutheran Church in Marquette. The annual distribution will be 6 percent of the assets of the fund. The fund agreement cites that distributions could result in the fund being exhausted.

The Synod Council and Endowment Fund Committee have interpreted Michigan's version of the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds, absent explicit donor stipulations to the contrary. As of January 31, 2025, there were no such donor stipulations.

# 11. Endowment Funds (continued)

The Synod interprets the donor-restricted endowment fund balances as being subject to appropriation for expenditure in a manner consistent with the standard prudence prescribed by UPMIFA. In accordance with UPMIFA, the Synod considers the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds:

- The duration and preservation of the endowment fund
- · The purposes of the Synod and the donor-restricted endowment fund
- General economic factors
- The possible effect of inflation or deflation
- The expected total return from income and appreciation of investments
- Other resources of the Synod
- The investment policy of the Synod

The spending policy (amended May 9, 2015) will allow for an annual appropriation of a minimum of 5 percent and a maximum of 8 percent of the average market value of the fund, as determined on January 31 of each of the preceding five years. All distributions will be from current and accumulated earnings of dividends and interest. The policy will be reviewed at least annually by the Synod Council and Endowment Fund Committee. It will be revised or confirmed, as appropriate, by the Synod Council.

The endowment funds are primarily invested in the ELCA Endowment Fund Pooled Trust – Ministry Growth Fund.

### 12. Concentration of Risk

Concentration of Credit Risk: The Synod maintains cash at a financial institution that is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of January 31, 2025, the Synod had cash deposits in excess of FDIC-insured limits of approximately \$316,000.

Concentration of Contribution Revenue: The Synod is located in Marquette, Michigan. The Synod receives its revenues from congregational contributions throughout the Upper Peninsula of Michigan and Northeastern Wisconsin. Congregation contributions accounted for approximately 86 percent of total revenues for the year ended January 31, 2025.

#### GUIDELINES FOR MEMORIALS AND RESOLUTIONS

### I. What is the difference between a memorial and a resolution?

Although both memorials and resolutions are requests by a synod for action, they are intended to address different issues, address different bodies, and are processed differently.

**Memorials** address broad policy issues and are passed by synod assemblies for consideration by the Churchwide Assembly. Only a synod assembly may address a memorial to the Churchwide Assembly. Synod councils are not authorized to adopt memorials.

Once a memorial has been adopted by your Synod Assembly, it is forwarded to the Office of the Secretary so it can be submitted to the Churchwide Assembly. One of the responsibilities of the Churchwide Assembly, in accordance with provision 12.21.c. of the Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America (CBCR), is to "receive and consider proposals from synod assemblies." Once received by the churchwide organization, memorials are referred to the Memorials Committee, which is appointed by the Church Council to review and make recommendations to the Churchwide Assembly, in accordance with bylaw 12.51.02. (CBCR). The Memorials Committee meets in the year of a churchwide assembly after all synod assemblies are over.

Resolutions are requests from synods to the Church Council or units or offices of the churchwide organization. Either synod assemblies or synod councils may originate resolutions. As a practical matter, resolutions have a narrower focus than memorials because they are requests for consideration or action by the Church Council or by individual units or offices of the churchwide organization by way of the Church Council Executive Committee. Frequently, synod councils will pass resolutions between meetings of their Synod Assembly and forward them to the Church Council for consideration, or to the Church Council Executive Committee if the desired action involves referral to a unit or office of the churchwide organization.

### II. Which body should be addressed by a memorial or a resolution?

Essentially, there are three avenues for synods to request action by the churchwide expression:

- 1) synod assemblies may address the Churchwide Assembly through memorials;
- synod councils may address the ELCA Church Council through resolutions;
- synod councils may address churchwide units or offices through resolutions sent to the ELCA Church Council's Executive Committee (including forwarding resolutions adopted by synod assemblies).

A resolution and a memorial may *not* be combined in one action. In addition, a synod should not address both the Church Council and the Churchwide Assembly on the same subject.

The Office of the Secretary, with the concurrence of the Executive Committee of the Church Council, may decide whether a proposal that has been received is to be classified as a memorial or as a resolution. In these circumstances, the synod will be notified promptly of the re-classification.

It is important to note that resolutions and memorials may not direct the churchwide organization to take action because of the principle of interdependence of the three expressions of this church (churchwide organization, synods, and congregations). They are proposals requesting a specified action. Memorials may request that the Churchwide Assembly urge synods and congregations to do something the writers desire, but a memorial should not assume that the Churchwide Assembly can compel synods or congregations to do these things. Similarly, resolutions may request that the Church Council or units or offices of the churchwide expression take a desired action, but the principle of interdependence applies here, as well.

### III. Drafting Memorials and Resolutions

Both memorials and resolutions are forms of main motions under *Robert's Rules of Order, Newly Revised* (12th ed.), Section 10.\* A main motion is simply a motion that brings business before the assembly. It is the basic mechanism to present a matter to the assembly for possible action.

Resolutions and memorials frequently contain both "resolved" clauses and "whereas" clauses. "Resolved" clauses state the action to be taken by the assembly; "whereas" clauses constitute a preamble describing the reasons for the proposed action. "Whereas" clauses are *not* required; in fact, *Robert's Rules of Order*, *Newly Revised* (12th ed.), 10:16, discourages their use:

In general, the use of a preamble should be limited to cases where it provides little-known information without which the point or the merits of a resolution are likely to be poorly understood, where unusual importance is attached to making certain reasons for an action a matter of record, or the like.

If "whereas" clauses are used, there should be as few as necessary. They should be succinct and factual. They should not be argumentative. The Resolutions/Reference and Counsel Committee should ensure that any "whereas" clauses comply with Robert's Rules of Order.

The "resolved" clauses represent the actual motion being voted upon. "Resolved" clauses, if adopted, become the officially worded statement of an action taken by a legislative body and a request for further action by the churchwide organization or the Churchwide Assembly. This means that they should be concise, accurate, and complete. They also should be unambiguous and should state clearly the proposed action. Just as any main motion, "resolved" clauses should not employ offensive language that would be improper in debate.

Some resolutions and memorials should not be considered. Any resolution or memorial that conflicts with the governing documents of this church is an "improper motion." As stated in *Robert's Rules of Order, Newly Revised* (12th ed.), 39:5:

Motions that conflict with the corporate charter, constitution, or bylaws of a society, or with procedural rules prescribed by national, state, or local laws, are not in order, and if any motion of this kind is adopted, it is null and void.

Synod councils are encouraged to work closely with the Resolutions/Reference and Counsel Committee to be certain that resolutions and memorials do not conflict with the governing documents of this church and that they meet the required criteria.

Memorials must always include a final "resolved" clause asking the Churchwide Assembly to act (or refrain from acting) in a particular way. Here is a sample final paragraph of a memorial from a synod assembly:

The final "resolved" clause of **resolutions** will differ depending upon whether they are intended for the attention of the Church Council or a churchwide unit or office. Here are sample final clauses for resolutions:

### IV. Review and Processing of Draft Memorials and Resolutions

Synods generally provide that memorials and resolutions (as well as other main motions) be referred to a Resolutions Committee, which frequently is called a Reference and Counsel Committee. Regardless of its name, a conscientious and well-trained committee can screen proposed actions and thereby facilitate discussion of important issues and save valuable time at synod assemblies.

The scope of authority of the Resolutions/Reference and Counsel Committee varies, depending on the governing documents and rules of organization and procedure of the synod. In the simplest arrangement, the Resolutions/Reference and Counsel Committee only has the power to put memorials, resolutions, and main motions in the proper form, eliminate duplication where similar motions are offered, and ensure all motions relating to a specific subject will be offered in logical sequence. In other cases, the synod's rules may authorize the Resolutions/Reference and Counsel Committee to make substantive edits and alterations in memorials, resolutions, and main motions. In all cases, the committee must report all motions referred to it, although the committee can report motions without a recommendation.

If a synod so desires, its rules of organization and procedure or a continuing resolution can provide additional authority for the Resolutions/Reference and Counsel Committee. For example, a synod could provide that in reviewing proposed memorials, resolutions, and main motions, the Resolutions/Reference and Counsel Committee may edit, prepare an alternative memorial, resolution, or main motion, or consolidate into a single proposed action multiple memorials, resolutions, or main motions on the same or similar subjects. In these circumstances, the Resolutions/Reference and Counsel Committee should confer with the makers of the original memorial or resolution. In addition, whenever the Resolutions/Reference and Counsel Committee recommends an edited or alternative memorial, resolution, or motion, the report to the assembly should contain the original maker's text.

Here is a sample provision authorizing editing by the Resolutions/Reference and Counsel Committee:

In reviewing proposed memorials, resolutions, and main motions, the Resolutions/Reference and Counsel Committee may edit, prepare an alternative memorial, resolution, or motion, or consolidate into a single proposed action multiple memorials, resolutions, or main motions on the same or similar subjects. Whenever the Resolutions/Reference and Counsel Committee recommends an edited or alternative memorial, resolution, or motion, the report to the assembly also shall contain the original maker's text.

Regardless of the scope of editorial authority, a Resolutions/Reference and Counsel Committee should consider at least the following factors in evaluating memorials and resolutions:

- Is the proposed memorial or resolution timely (i.e., was it submitted before the deadline)?
- 2) Is the proposed memorial or resolution consistent with the governing documents of this church?
- 3) Is the proposed memorial or resolution germane to issues on the agenda?
- 4) Does the proposed memorial or resolution address a priority, ministry, or concern of this synod and this church?
- 5) Is the proposed memorial or resolution clearly drafted?
- 6) Do the "resolved" clauses clearly define the proposed course of action?
- 7) If the proposed memorial or resolution contains "whereas" clauses, do they explain the proposed action and are they accurate and non-argumentative?
- 8) Does the proposed memorial or resolution have possible budgetary or human resource implications?
- 9) Are the proposed actions feasible and appropriate for the Synod Assembly, Church Council, Churchwide Assembly, or the churchwide unit or office that will be addressed?
- 10) Are there other memorials or resolutions that address the same or similar issues?

Interdependence, as well as stewardship of resources, requires that care be taken to avoid resolutions and memorials whose effect would be to impose unreasonable financial demands on the churchwide organization, synods, or congregations. If a proposed resolution or memorial will impose an unfunded mandate if adopted, synod councils are requested to consider the proposed action before it is submitted to a synod assembly. Synods also are requested to advise their synod councils and synod assemblies that the churchwide organization may not be able to support requested resolutions or memorials for budgetary reasons and that, if adopted, such proposed actions may have adverse consequences on existing programs or ministries. As interdependent partners, it is important for synods and the churchwide organizations to work collaboratively.

After the Office of the Secretary receives the memorial from the synod, the Office of the Secretary will reach out to the appropriate unit or office in the churchwide organization to request a summary of potential financial and staff implications that will be included in the background information for the Churchwide Assembly. If questions exist regarding the potential implications of a proposed resolution or memorial, inquiries to the Office of the Secretary are encouraged.

It is important that any resolutions pertaining to proposed amendments to the Constitutions, Bylaws, and Continuing Resolutions of the ELCA be acted on as resolutions from your Synod Council to the Church Council, rather than as memorials to the Churchwide Assembly. Your Synod Assembly can still act on a resolution, but what the Synod Assembly should be voting on is to direct your Synod Council to forward the assembly's resolution to the Church Council for consideration by the Churchwide Assembly.

The synod's rules of organization and procedure also should address how the Resolutions/Reference and Counsel Committee reports to the Synod Assembly and the status of its recommendations.

Here is a sample of a provision, based on the "Rules of Organization and Procedure for the Churchwide Assembly," that addresses the status of recommendations of the Resolutions/Reference and Counsel Committee:

The Resolutions/Reference and Counsel Committee shall report its recommendations on memorials, resolutions, and main motions to the Synod Assembly. Such recommendations do not require a second. When the Resolutions/Reference and Counsel Committee recommends approval, the committee's recommendation shall be the main motion before the assembly. When the Resolutions/Reference and Counsel Committee recommends the adoption of a substitute or alternative motion, the committee's recommendation shall be the main motion before the assembly. When the Resolutions/Reference and Counsel Committee recommends referral, the committee's recommendation shall become the main motion before the assembly. When the Resolutions/ Reference and Counsel Committee recommends that the assembly decline a proposed memorial, resolution, or main motion, the recommendation shall be reported to the assembly. If the author or another voting member wishes to bring the declined proposed memorial, resolution, or main motion to the floor, the voting member may move the matter, and it shall become the main motion before the assembly, and the committee's recommendation shall be received for information.

### V. Submission of Resolutions and Memorials to the Churchwide Organization

For proper recording and disposition, synods must submit all resolutions and memorials in a timely manner to the secretary of this church (and not directly to churchwide units or offices). Following the Synod Assembly, to report any approved memorials, election of new officers and their term dates and contact info, amendments to your synod constitution, and other important Synod Assembly actions, use this <u>online form</u>. # PROPOSED RULES AND ORDER OF PROCEDURE MAY 2025 SYNOD ASSEMBLY

Robert's Rules of Order Latest Edition, (12<sup>th</sup> ed.), shall govern all parliamentary procedure of the Synod Assembly. (S7.32.)

- 2. One half of the members of the Synod Assembly shall constitute a quorum. (S7.14.)
- 3. The membership of the Synod Assembly, of which at least sixty (60) percent of the voting membership shall be composed of lay persons, shall be constituted as follows (†S7.21):
  - a. All ministers of Word and Sacrament under call on the roster of this Synod in attendance at the Synod Assembly shall be voting members. (†S7.21.a.)
  - b. All ministers of Word and Service, under call, on the roster of this Synod shall be voting members in the Synod Assembly, in addition to the voting membership of lay members of congregations provided in item †\$7.21.c. (†\$7.21.b.)
  - c. A minimum of one lay member elected by each congregation with fewer than 175 baptized members and a minimum of two lay members elected by each congregation with 175 or more baptized members related to this synod, normally one of whom shall be male and one of whom shall be female, shall be voting members. The Synod Council shall establish a formula to provide lay representation from congregations on the basis of the number of baptized members in the congregation. The Synod Council shall seek to ensure that, as nearly as possible, 50 percent of the lay members of the assembly shall be female and 50 percent shall be male. Additional members from each congregation shall be equally divided between male and female. (†S7.21.c.)

The formula established by the Synod Council for the number of lay voting members (as of December 31<sup>st</sup> of the previous year) from a congregation is as follows:

d. Voting membership of the Synod Assembly shall include the officers of this synod. (†S7.21.d.)

- e. Congregations served by a Licensed Lay Minister at the time of the Synod Assembly, where no rostered leader is currently under call to the congregation, shall be accorded one additional voting member to the assembly for each Licensed Lay Minister serving the congregation, provided that the additional voting member is the Licensed Lay Minister. (S7.21.A04.)
- f. All retired rostered ministers of this Synod in attendance at the Synod Assembly shall have the privilege of voice, and a specified number of those in attendance will be voting members. (See S7.22. for voting member assignment process based on date and time order of Assembly registration.)
- g. Duly elected voting members of the Synod Council who are not otherwise voting members of the Synod Assembly under †\$7.21 shall be granted the privilege of both voice and vote as members of the Synod Assembly. (\$7.28.)
- h. This synod may establish processes through the Synod Council that permit representatives of authorized worshiping communities of the synod, under ELCA bylaw 10.01.04., to serve as voting members of the Synod Assembly, consistent with †S7.21. (S7.26.)
- i. This synod may establish processes through the Synod Council to grant a minister from a church body with which a relationship of full communion has been declared and established by the Churchwide Assembly of the Evangelical Lutheran Church in America the privilege of both voice and vote in the synod assembly during the period of that minister's service in a congregation of this church. (S7.27.)
- j. The presiding bishop of the Evangelical Lutheran Church in America and such other official representatives of the churchwide organization as may be designated by the presiding bishop shall have voice but not vote in the meetings of the Synod Assembly. Like privileges shall be accorded to those additional persons whom the Synod Assembly or the Synod Council shall from time to time designate. (†S7.23.)
- k. Voting members shall begin serving with the opening of a regular Synod Assembly and shall continue serving until voting members are seated at the next regular Synod Assembly. (†S7.21.01.)
- 4. With the consent of the Assembly, the Chair shall have the authority to call items of business before the Synod Assembly in whatever order they consider most expedient for the conduct of the Assembly's business.
- 5. All motions except routine ones shall be submitted in writing on the form provided by the Synod Secretary.
- 6. All speeches in general discussion, unless otherwise determined by a two-thirds vote of this Assembly, shall be limited to three minutes.
- 7. Permission to distribute materials not issuing from the Assembly Office must be secured from the Assembly Resolutions Committee and distributed through them.

- 8. No proxy or absentee voting shall be permitted. (†S7.31.)
- 9. The Chair of the Assembly may count abstentions only to record that number in the minutes. Abstentions are not counted in determining the adoption of a resolution or motion.
- 10. All reports published in the pre-assembly report shall be received by the Synod Assembly by virtue of that fact without vote. (S7.11.72.)

# CREDENTIALS COMMITTEE

The bishop shall appoint a credentials committee consisting of three members, one of whom shall be the registrar for the Synod Assembly. (S7.11.30.)

- a. Members of the committee shall serve three-year terms, with one-third of the terms expiring each year. No member of the committee shall be eligible to serve more than two consecutive terms. (S7.11.30.a.)
- b. The committee shall examine the credentials of all members of the Synod Assembly and shall prepare a list of voting members, which shall be reported at the opening and closing of the Synod Assembly. (S7.11.30.b.)

# **RULES GOVERNING ELECTIONS**

# NOMINATING COMMITTEE

1. There shall be a Synod Assembly Nominating Committee consisting of one member from each Conference who shall be appointed by the Synod Council to serve for each regular meeting of the Synod Assembly. (S9.03)

It is expected that the Nominating Committee will observe the guidelines for inclusiveness as specified in †S6.04.

- 2. Additional nominations may be made from the floor for all elections for which nominations are made by the Nominating Committee. (S9.03.)
- 3. The report of the Nominating Committee shall be in the first session of the Assembly. The report shall designate incumbents in office with an asterisk.
- 4. Before any person's name is placed in nomination, consent shall have been received from that person by the Nominating Committee or the person nominating from the floor.

- 5. A brief resume of approximately fifty words regarding each nominee shall be presented in the report. The resume may include the following information name, address, occupation, congregational membership, age category, gender, church activities, community activities, and whether a person is a member of a minority group or of a group whose primary language is other than English.
- 6. Individuals nominated from the floor may distribute the same type of written resume, as described above, before the election. All biographical information must be presented to the Nominating Committee who must distribute it.

# **ELECTIONS COMMITTEE**

The bishop shall appoint an Elections Committee consisting of six members. (S7.11.40.) In the case of a hybrid assembly by conference, there will be 9 members of the Election Committee, composed of one person from each conference plus the Chair of the Elections Committee.

- a. Members of the committee shall serve-three-year terms, with one-third of the terms expiring each year. No member of the committee shall be eligible to serve more than two consecutive terms. (S7.11.40.a.)
- b. The committee shall supervise elections, keep a correct list of voters, and announce the results to the Synod Assembly. (\$7.11.40.b.)

# **ELECTIONS**

- 1. In all elections, other than for bishop, names will be placed on the first ballot at random by means of lot.
- 2. In all elections, other than for bishop, the highest number of votes and a majority of legal votes cast for the position shall constitute an election. (S9.02.)
- 3. In all elections, except for the bishop, the names of the persons receiving the highest number of votes, but not elected by a majority of the legal votes cast on a preceding ballot, shall be entered on the next ballot to the number of two for each vacancy unfilled. (S9.08.)
- 4. In all elections, other than for bishop, on the second, third, fourth and fifth ballot, the names of persons are to be listed in descending order according to the number of votes received on the preceding ballot. If further balloting is required, the Elections Committee will make the necessary arrangements.
- 5. The results of each ballot in every election shall be announced in detail to the Assembly. (S9.09.) On the basis of the results of the balloting, the Chair of the Assembly shall announce whether or not there has been an election.
- 6. A member of the Elections Committee shall be in charge of each ballot box.

7. The Elections Committee shall report to the Assembly as soon as the ballots are counted, when called for by the Assembly Chair.

# **RULES GOVERNING RESOLUTIONS**

# RESOLUTIONS COMMITTEE

- 1. The Synod Council shall appoint a Resolutions Committee consisting of six Synod Council members. (S7.11.50.)
  - a. Members of the committee shall serve for two years, with approximately one-half of the terms expiring each year. No member of the committee shall be eligible to serve more than two consecutive terms. (S7.11.50.a.)
  - b. The committee shall review all memorials and resolutions submitted later than thirty days prior to the opening of the Synod Assembly to determine, under the provision of bylaw S7.11.60., whether they shall be considered by the Synod Assembly, and to recommend action by the Synod Assembly on those which are to be considered. The Resolutions Committee shall report a brief description to the Synod Assembly of all resolutions received by them and of the disposition made of each resolution. (S7.11.50.b.)
  - c. In reviewing proposed memorials and resolutions the Resolutions Committee may edit, prepare an alternative memorial or resolution, or consolidate into a single proposed action multiple memorials or resolutions on the same or similar subjects. Whenever the Resolutions Committee recommends an edited or alternative memorial or resolution, the report to the assembly also shall contain the original maker's text. When editing, preparing an alternative memorial or resolution, or consolidating into a single proposed action multiple memorials or resolutions on the same or similar subjects the Committee shall make reasonable efforts to communicate with the makers of all memorials and resolutions involved.
- 2. Memorial and resolution guidelines shall be sent to all members of the committee prior to the beginning of the Assembly.
- 3. All memorials and resolutions received by the Synod less than 30 days prior to the Assembly will be forwarded to the committee. (S7.11.60.)
- 4. At a time specified by the Chair of the committee, prior to the beginning of the Assembly, a poll will be made of the committee to establish the following criteria:
  - a. categorize the memorials and resolutions by like subject,
  - b. determine which memorials and resolutions need additional background information, clarification or amendment,
  - c. if changes or additional information is needed, notify the maker and other reported to the Assembly. If the author or another voting member wishes to bring the declined proposed memorial or resolution to the floor, he or she may move the matter, and it shall become the main motion before the assembly; and the Resolutions Committee recommendation shall be received by the Assembly as information.

### **RESOLUTIONS**

- 1. To assure presentation to the Assembly, memorials and resolutions must be submitted to the Bishop not later than thirty days prior to the opening of the Synod Assembly. All memorials and resolutions received by the Bishop are presented to the Synod Assembly after review by, and recommendation of, the Synod Council. No memorial or resolution received subsequent to that date shall be accepted for consideration by the Synod Assembly unless the Resolutions Committee judges it to be a matter of sufficient importance and urgency which is not adequately covered by documents already before the Synod Assembly, except that memorials and resolutions relevant to matters under consideration by the Synod Assembly may be accepted at the time that the matter is being considered. (S7.11.60.)
- 2. Prior to the beginning of a Synod Assembly, memorials and resolutions may be submitted to the Assembly only by member congregations and conferences of the Synod, by the Synod Council, by the Synod Executive Committee, by committees and auxiliaries of the Synod, by schools or agencies of the ELCA located in and related to the Synod, by officers of the Synod, and by conference pastoral associations. Individual voting members to the Assembly may submit memorials and resolutions at the Assembly subject to the provisions of bylaw S7.11.60. (S7.11.61.)
- 3. Only voting members may introduce memorials and resolutions during the Assembly subject to the provisions of bylaw S7.11.60.
- 4. Authors of memorials and resolutions may be asked to provide additional information regarding the memorial or resolution to document accuracy.
- 5. Any memorial or resolution that conflicts with the governing documents of the Evangelical Lutheran Church in America or the Northern Great Lakes Synod will be considered out-of-order, per *Roberts Rules of Order, Newly Revised* (12<sup>th</sup> ed.) section 39:5, page 326.
- 6. Policies and positions already established by the Evangelical Lutheran Church in America and the Northern Great Lakes Synod will serve as criteria when addressing issues through memorials and resolutions.
- 7. All memorials and resolutions presented at the Assembly must be printed clearly on the Resolution Form provided by the Synod Secretary.
- 8. Memorials and resolutions affecting the budget of the Synod require a two-thirds majority vote for adoption. (S10.04.)
- 9. All authors of potential memorials and resolutions are strongly encouraged to consult the document "2025 Information and Guidelines for the Drafting of Memorials and Resolutions" available from the Synod Secretary or the Synod website (<a href="www.nglsynod.org">www.nglsynod.org</a>). The Synod Bishop and the Synod Secretary are also available for consultation regarding memorials and resolutions.

# **Report of the Synod Constitutions Committee**

The Synod Constitutions Committee is appointed by the Bishop to carry out the Synod's responsibility to approve or disapprove any changes to congregation constitutional provisions:

\*C16.03. Any amendments to this constitution that result from the processes provided in \*C16.01. and \*C16.02. shall be sent by the secretary of this congregation to the synod. The synod shall notify this congregation of its decision to approve or disapprove the proposed changes; the changes shall go into effect upon notification that the synod has approved them.

2022 Model Constitution for Congregations

It has been tradition in our Synod for the Synod Secretary to chair the Constitutions Committee with assistance from Synod staff and committee work by Synod Council members and other volunteers with congregation governance experience. I give thanks for the work of our current Constitutions Committee members: Synod Vice President Chuck Thomas, Synod Council member Gabriel Lannet, Richard Reitz, Trinity, Rhinelander and Pastor Paul Heykes, Calvary, Minocqua.

The committee continued to use a regular work cycle (December-March, April-July, and August-November) to review constitutions that are submitted for the required Synod approval. In addition to the formal review, committee members will also include recommendations for non-required changes to improve governance or prevent potential problems. In most cases we try to review drafts ahead of a congregational vote so that needed corrections can be made before the fact.

We encourage all congregations to know their constitutions and bylaws and regularly review and update them. In addition to the required and suggested updates in the 2022 Model Constitution for Congregations, you may also find that some of your existing provisions for council or committee structure don't meet your current situation and needs. The Constitutions Committee is ready to assist your congregation in this review and amendment process. To get started, see the Synod website "Congregation Council Resources" page which includes the 2022 Model Constitution, downloadable in both Word and PDF formats, a memo of alternative governance provisions for small congregations developed by our Committee members and our review schedule for your work planning.

Our committee looks forward to being your congregation's partner in governance work.

# #3: Amend Synod Bylaws Regarding Endowment Board

Submitted by Synod Council

WHEREAS, changes in management of the synod's Endowment Funds means that a separate Board structure is no longer required for necessary oversight duties; and

WHEREAS, the oversight duties no longer require as many volunteer members; and

WHEREAS, there is a conflict in the current bylaws between the language of S11.01.50 and subpart i of S11.01.51; and

WHEREAS, Synod Council has approved a recommendation that an administration fee be added to the Endowment Fund governance policy:

RESOLVED, that Synod bylaws S11.01.50 and S11.01.51 be amended to read:

S11.01.50. There shall be an Endowment Ministry Fund Board Committee which shall administer the Northern Great Lakes Synod Endowment Funds. These funds shall consist of an unrestricted fund known as the Equipping the Saints Fund and Restricted Funds. Distributions shall be made annually from the unrestricted fund and shall total an amount from 5 to 8 percent of the 5-year running average of the fund's value as determined on January 31 of each year. Restricted Funds shall be used in accordance with specific directions associated with the fund. The purpose of these funds shall be to enable the further growth of our church, its ministries, and stewardship opportunities apart from the general operation of the synod. The Endowment Ministry Fund Committee shall consist of the Synod Bishop, the Synod Treasurer, and 8-15 at least 5 and no more than 10 at-large other members appointed by the Synod Council for three-year terms, with reappointment permissible and one-third of the terms to expire each year. The board committee shall elect from its membership a chair, a vice-chair, and a secretary. The Synod Treasurer shall serve as treasurer of the board committee.

### **S11.01.51.** The Endowment Ministry Fund Board Committee shall:

- A. Directly or through the synod receive funds from gifts, memorials, bequests, wills, estates, etc., of any individual, corporation, or organization or from any other source in cash or in other property acceptable to it. All trust funds shall be kept and maintained separate, distinct, and independent from the funds and property otherwise belonging to the synod;
- B. Be responsible for the prudent investment of the endowment funds;
- C. Investigate specific projects and purposes to be funded by the endowment funds. The committee shall seek recommendations for use of the endowment funds from the Synod Council, the bishop, and others as appropriate;
- D. Contribute, donate, support or distribute, from time to time, for its purpose such payments or amounts as the Endowment Ministry Fund Committee in its discretion shall determine;
- E. Working with the Synod Treasurer and the Synod Bookkeeper, annually render a full and complete account of the administration of the endowment funds to the Synod Council. The committee may designate an annual administration fee from the unrestricted Equipping the Saints Endowment Fund and where allowed, from select restricted endowment funds to compensate the synod for its administration costs associated with the funds. The administration fee may be up to 3 percent of the December 31 values of each fund;
- f. Develop and pursue fund-raising activities including encouragement and enlistment of resources and cultivation of gifts to the Equipping the Saints Fund and Restricted Funds through bequests, annuities, deferred giving, and other sources;
- g. Develop policies appropriate to its purpose and function;
- h. Working with the Synod Bishop, supervise any employee of the synod engaged to work with the Synod Endowment Fund; and
- i. Bring to a Synod Assembly for its consideration a resolution which would disburse any principal other than the minimum distribution as described in S11.01.50. The favorable recommendation of the Endowment Ministry Fund Board Committee, the Synod Council, and adoption by at least two-thirds of those present and voting at a Synod Assembly shall be required before any principal or corpus shall be disbursed except as described in S11.01.50.

# #4: Distribution for Regional Gift Planner

Submitted by the Endowment Ministry Committee

<u>WHEREAS</u>, the Endowment Fund of the Northern Great Lakes Synod (NGLS), now known as the Equipping the Saints Fund, since its inception in 1989 has relied upon the development work of the synod staff and the Endowment Ministry Committee; and

<u>WHEREAS</u>, the Endowment Ministry of the NGLS continues to benefit from a professional development person who assists members of this church with their charitable planning, wherein the fund grows as does the grants made by it annually to the ministries of the Northern Great Lakes Synod; and

<u>WHEREAS</u>, the Synod Bylaws S11.01.51.i requires that before any disbursement of the perpetual fund principal, the recommendation of both the Endowment Ministry Committee and the Synod Council be secured, such recommendation occurring; therefore be it

RESOLVED that the Northern Great Lakes Synod approve the disbursement of not more than \$20,000 per year, for three years, a total disbursement of \$60,000 in Endowment Fund principal pursuant to \$11.01.51.i for the expenses of a development person to represent the Northern Great Lakes Synod Endowment Ministry funds.

# **#5: Compensation Guidelines for 2026**

RESOLVED, that the document "Support of Ministry Partnerships" that includes Clergy Compensation Guidelines for 2026 as approved by the Synod Council and amended by the Executive Committee hereby be adopted and recommended to this Synod's congregations.

### #6: Memorial Re: National Day of Remembrance for Indian Boarding Schools

Submitted by the NGLS Walking with Our Indigenous Neighbors Task Force

WHEREAS, from 1819 to 1969, countless Indian day schools and over 520 Indian boarding schools operated in the United States, with 417 receiving federal support [1], where Native children were forcibly taken from their families and communities, prohibited all expression of Native language and culture, and required to perform manual labor [2], with a goal to "Kill the Indian in him, and save the man" [3]; and

WHEREAS, religious organizations collaborated with the federal government in operating more than half of these federally-funded schools; and predecessor denominations of the Evangelical Lutheran Church in America (ELCA) operated Bethany Indian Mission Boarding School in Wittenburg, Wisconsin [4], and other non-federally funded boarding schools, day schools, and related institutions [5]; and

WHEREAS, these schools were part of a larger strategy of physical and cultural genocide that included forcing Indigenous people and Tribal Nations off of their original homelands and onto reservations so that settlers and governments could claim the stolen land for themselves, undermining sovereignty [6], and perpetrating extermination in multiple other ways; and

WHEREAS, boarding school students, which at one point included over 83% of all Native children [7], often suffered physical, sexual, emotional, and psychological abuse that caused deep trauma for the children, their families, their tribal communities, and subsequent generations [8]; and an untold number of children died while at boarding schools (nearly 1,000 identified to date) [9]; and

WHEREAS, the ELCA has committed to work against injustices and toward healing as stated in "The Repudiation of the Doctrine of Discovery" (2016) [10] and the "Declaration to American Indian and Alaska Native People" (2021) [11], therefore be it

RESOLVED, that the Northern Great Lakes Synod Assembly memorialize the 2025 Churchwide Assembly of the Evangelical Lutheran Church in America to address the legacies of our church's role in Indian Boarding Schools through the following actions:

- 1. Actively invite and equip all congregations, synods, and affiliate ministries to commemorate the National Day of Remembrance for Indian Boarding Schools annually on or near September 30th;
- 2. Broaden and deepen awareness at congregation, synod, and churchwide levels of Christian and Lutheran roles in Indian boarding schools, through creation of adult and children/youth educational programs and materials and by regularly posting articles in the church's publications;
- 3. Provide on-going recognition of and support for the growing network of lay people and clergy volunteering their time in the work of the ELCA Truth-Seeking & Truth-Telling Initiative on Indian Boarding Schools (see www.elca.org/IndianBoardingSchools) to locate all known records related to the ELCA's predecessor bodies' involvement with Indian boarding and day schools and to educate others about Indian boarding schools;
- 4. Encourage ELCA affiliate ministries to commit to learning the truth of their involvement with Indian boarding schools, in partnership with the ELCA Truth-Seeking & Truth-Telling Initiative; and to responsibly create paths to healing and repair;
- 5. Organize and care for all information in the ELCA's possession that was recorded about Indian boarding and day schools and the students who attended them, whether they were forcibly removed or not; carry out this work in partnership with the ELCA Truth-Seeking & Truth-Telling Initiative and the ELCA Archives; recognize that this information belongs to and is a source of healing for student survivors, their descendants, communities, and Tribal Nations; and ensure that the records and research are made accessible to Indian boarding school survivors and their families in a responsible manner; and
- 6. Identify sources of funding to sufficiently support research and organizing efforts; and to sufficiently support digitization and labeling of all ELCA Indian boarding school archival records.

# #9: Amend Synod Constitution S8.42e re: audit timing

WHEREAS, annual financial audit costs for the Synod have risen substantially from \$8,300 for the 2023 audit to \$13,000 for the 2024 audit; and

WHEREAS, the Synod has been unable to engage a different audit firm to lower cost, since only our current public accounting firm responded to the Synod's request for proposals last year; and

WHEREAS, the current Synod Constitution provision S8.42e requires the Synod Treasurer to "render at each regular meeting of the Synod Assembly a full, detailed and duly audited report of receipts and disbursements in the several accounts of this synod **for the preceding fiscal year...**" which means that for the spring 2025 Synod Assembly the audit of 2024 must be completed during the accounting profession's busiest time, first and second quarter; and

WHEREAS, the Synod could lower costs for our financial auditing if the required schedule allowed the audit to occur at a different, less busy time of year;

RESOLVED, that S8.42e be amended by replacing "for the preceding fiscal year" with "for the year prior to the preceding fiscal year".
