## Our Synod's Endowment Ministry

The Endowment Ministry of the Northern Great Lakes Synod exists to help individuals and congregations make lasting gifts to support the work of Christ in our Synod, the Church, and the world.

Our Synod Endowment Ministry consists of funds that are either restricted or unrestricted. The restricted funds have been designated to a particular ministry such as:

- Tanzanian Projects
- Seminarian Scholarships
- Clergy Debt Relief

Our unrestricted fund is the **Equipping the Saints Fund** which distributes 5% - 8% of the market value of its invested assets each year, approximately \$30,000 - \$40,000 annually.

During the past decade, over \$350,000 has been distributed from our **Equipping the Saints Fund** to a wide variety of organizations and ministries including:

- ❖ Youth Ministry
- ❖ Lifelong Faith Formation
- ❖ Leadership support & training
- ❖ Support for Campus Ministry at Bay College in Escanaba, MI.
- ❖ Synod Ministry efforts & programs

### How Can I Participate?

The best gift is one appropriate to your interests and circumstances. Gifts of all sizes are important and valued! Examples of gifts include the following:

- + **Outright Gifts or a Monthly Donation** of any amount in cash, real estate, or securities may be made at any time in memory of loved ones, in honor of others, in celebration of special events, and in thanksgiving for God's goodness.
- + **Life Insurance Policies**, existing or new, full or partial, may be donated.
- + **Bequests** through wills or trusts enable you to retain the asset during your life and provide significant support to the work of Christ after your death.
- + **Charitable Gift Annuities** are an irrevocable gift of cash or securities where you receive a predictable fixed income for life. At termination, the Synod would receive the residual value of the annuity.
- + **Qualified Charitable Distributions** are a giving opportunity for those over 70½ years of age to make tax free contributions from your IRA directly to the Synod Endowment Ministry.
